

Operation Instructions

TO POSITION JACK STANDS:

- 1. Set parking brake and block the wheels not being raised
- 2. Raise vehicle to desired height and insure it is stable.
- 3. Extend post to height of axle or flat reinforced framed surface.
- Check the Load Locking and Release Handle to insure that the tooth has been engaged on the post.
- Make sure both jack stands are at an equal height and will support the load evenly when the lifting device is removed.
- IMPORTANT: Place jack stands under support points specified by the manufacturer. DO NOT crawl under the vehicle when placing or removing stands.
- SLOWLY lower the load onto the jack stands and check to insure the load is located on the center portion of the saddle. If load is not located on the center of the saddle or if load is unstable, relift the load and reposition the jack stands to ensure proper positioning before continuing with work or repairs.

TO REMOVE JACK STANDS:

- 1. Carefully raise vehicle enough to clear the stands, making sure the vehicle remains stable.
- Remove stands, being sure not to crawl under the vehicle in the process.
- 3. Following instructions provided with your lifting device, carefully lower the vehicle to the ground.

Owner And/Or Operator Responsibilities

The owner and/or operator shall study the product instructions and retain them for future reference.

The owner and/or operator shall have an understanding of the product, its operating characteristics, and safety operating instructions before operating the PALD. Safety information shall be emphasized and understood. If the operator is not fluent in English, the product and safety instructions shall be read to and discussed with the operator in the operator's native language by the purchaser/owner or his designee, making sure that the operator comprehends their contents.

The PALD shall be maintained in accordance with the product instruction

- 1. When stand is not in use, the ratchet should be in fully lower position.
- 2. Always keep jack stand clean and wipe with oil cloth every two months.
- 3. Keep moving parts clean; lubricate moving parts every 3 months.

Visual inspection shall be made before each use of the PALD by checking for abnormal conditions, such as cracked welds, leaks, and damaged, loose, or missing parts.

Other inspections shall be made per product operating instructions.


Each PALD shall be inspected immediately if the device is believed to have been subjected to an abnormal load or shock. It is recommended that this inspection be made by a manufacturer's or supplier's authorized repair facility.

Owners and/or operators should be aware that repair of this equipment may require specialized knowledge and facilities. It is recommended that an annual inspection of the PALD be made by a manufacturer's or supplier's authorized repair facility and that any defective parts, decals, or safety labels or signs be replaced with manufacturer's or supplier's specified parts. Because of potential hazards associated with this type of equipment, no alterations shall be made to the product.

Only attachments and/or adaptors supplied by the manufacturer shall be used.
