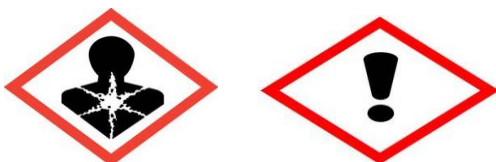

SECTION 4 - FIRST-AID MEASURES

4.1 Description of first aid measures

clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

7.2 Conditions for safe storage, including any incompatibilities: Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Keep in a dry place.

7.3 Specific end use(s): Use in a laboratory fume hood where possible. Refer to employer's COSHH risk assessment.
