DIRECTIONS FOR USE:

NOTE: Always check for colorfastness before using

CONCRETE, **STUCCO AND TILE**: Use full strength applying by trigger sprayer or roller. For best results, allow minimum contact time of 5 minutes, up to and no more than 10 minutes. Do not permit the treated surface to dry. Rinse with water. Repeat process if necessary. Coverage is approximately 200 square feet of surface per gallon of product.

CLOTHING AND CARPETING: This product is safe on most colorfast fabrics. Apply a few drops directly on stain. Allow contact time of approximately 5 minutes. After stain disappears, rinse well with cold water. Do not iron before rinsing and avoid contact with washer and dryer surfaces.

SINKS AND TOILET BOWL: Use only on white sinks and bowls. Apply product to stain. For best results, allow minimum contact time of 5 minutes, up to and no more than 10 minutes. Rinse. Repeat, if necessary until stain is gone. Repeat on deep stains. Avoid contact with any surface not specified in directions. Use only as directed.
