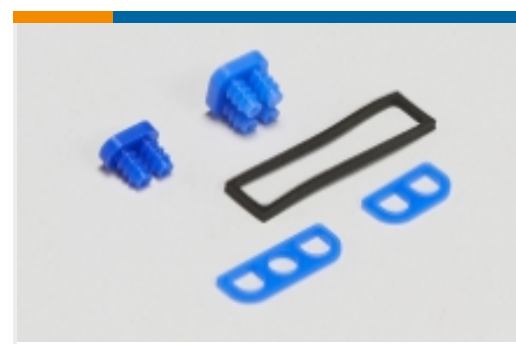




Rectangular Connector Keying Plugs(3)
