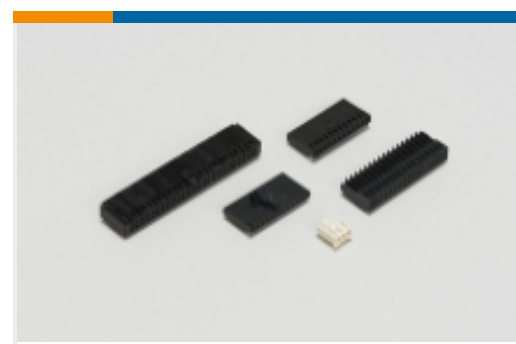




Rectangular Power Connectors(3)
